Delegation of Authority – 37 CFR 1.181(g)

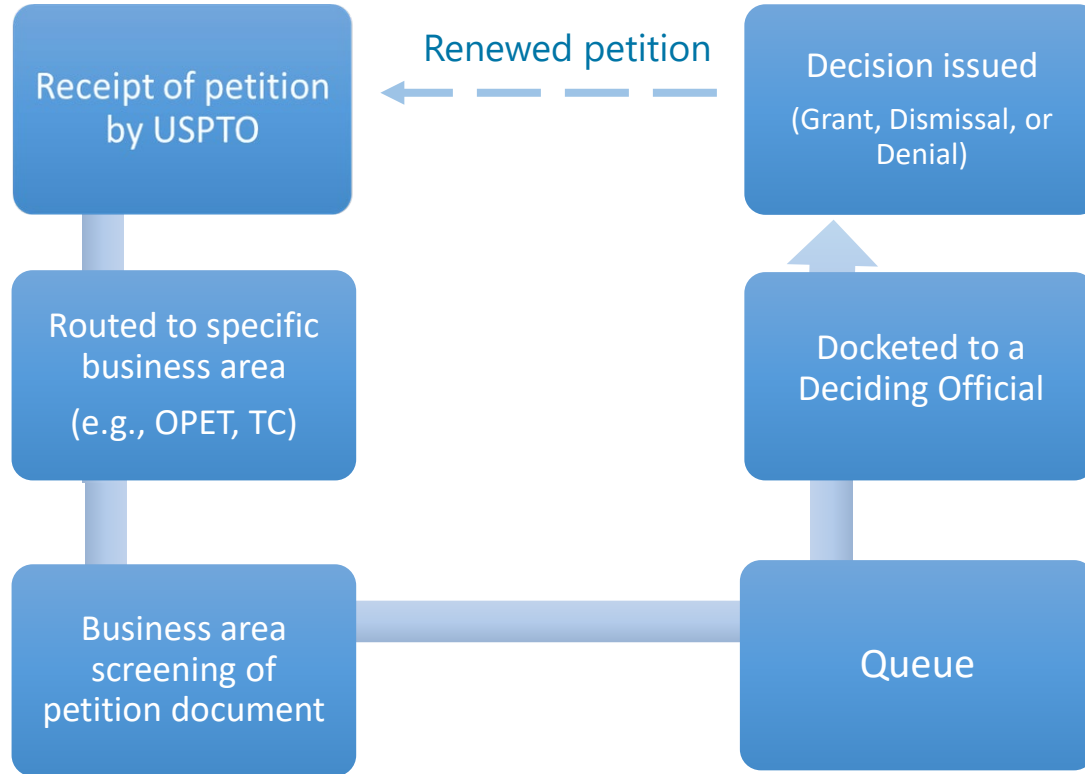
The authority to decide petitions to the Director of the USPTO not otherwise delegated, has been delegated to various Office officials such as:

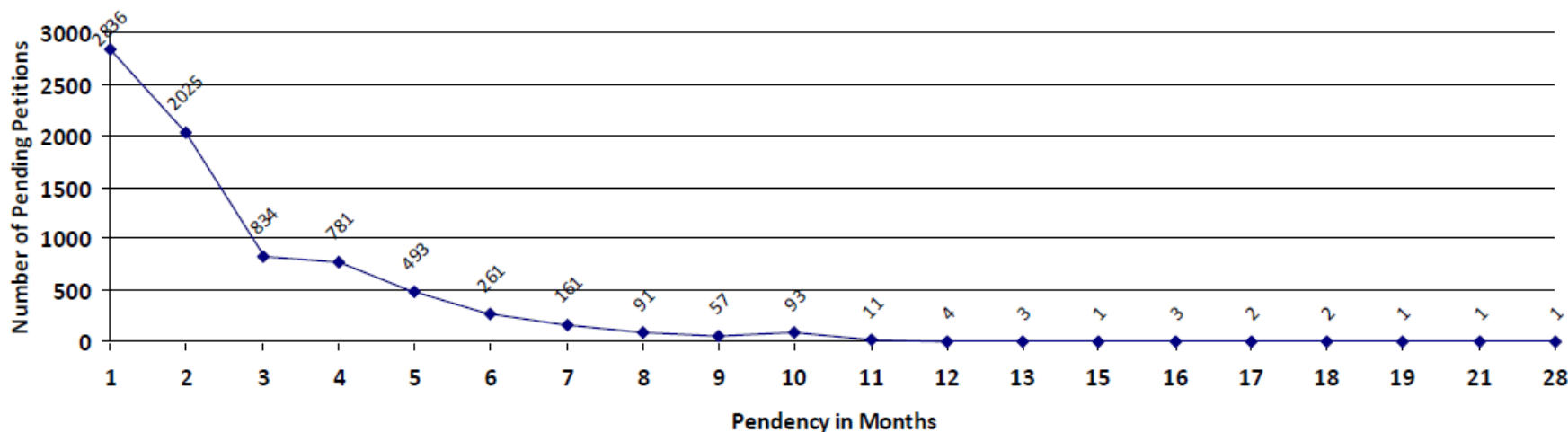
